Upgrading the Information and Communication Technology Infrastructure of the Ministry of Social Affairs (MoSA) in Lebanon by providing adequate hardware equipment, software and other needed supplies. This upgrade shall allow the smooth functioning of all information systems currently operated in the framework of MoSA's activities; it shall ensure the proper storage, transfer and security of data collected; it shall enhance the degree of automation and efficiency of MoSA's ICT infrastructure.

This upgrade will consist in the supply, delivery, installation and testing of all elements composing the proposed new configuration of the ICT infrastructure at MoSA premises. It will entail the purchase of new servers, SAN storage, firewalls, specific software and other minor items, as well as performing subsidiary ancillary services such as the installation of the equipment, its testing and the training of MoSA personnel.
