



### **TERMS OF PARTICIPATION**

## 8. Eligibility and rules of origin

Participation is open to all natural persons who are nationals of and legal persons [participating either individually or in a grouping (consortium) of tenderers] which are effectively established in a Member State of the European Union or in a eligible country or territory as defined under the Regulation (EU) N°236/2014 establishing common rules and procedures for the implementation of the Union's instruments for external action (CIR) for the applicable Instrument under which the contract is financed (see also heading 22 below). Participation is also open to international organisations.

The estimated budget of the tender procedure as a whole or if divided into lots, per lot, is over EUR 20.000. All supplies under this contract may originate from any country.

#### 9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the Practical Guide.

#### 10. Number of tenders

Tenderers may submit only one tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

## 11. Tender guarantee

No tender guarantee is required.

### 12. Performance guarantee

No performance guarantee is required.

## 14. Tender validity

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders. ### **SELECTION AND AWARD CRITERIA**

#### 16. Selection criteria

The following selection criteria will be applied to tenderers. The selection criteria will not be applied to natural persons and single-member companies when they are sub-contractors:

 Economic and financial capacity of tenderer. The reference period which will be taken into account will be the last three years for which accounts have been closed.

The selection criteria for each tenderer are as follows:

- the average annual turnover of the tenderer must exceed the annualised maximum budget of the contract; and
- 2) Professional capacity of tenderer. The reference period which will be taken into account will be the last 5 years from submission deadline and the bidder has a professional certificate appropriate to this contract.
- 3) Maximum points will be given to the Bidder that proposes the maximum numbers of units of bins for the total budget of 100.000 euros taking into account the minimum units proposed in Table 1: Specifications of Steel bins and Table 2:Specifications of plastic bins.

The tenderer has delivered supplies under at least five contract[s] with a budget of at least 100.000 EUR in Lebanon which were implemented during the following period: 5 years from the submission deadline.

4) Markings: Bins will be marked with the logos provided by ACCD in Annex A and the bidders will propose the design that will be evaluated with the proposal.


