2. Sealed tenders/bids must be submitted with 02 envelopes marked A (technical information) & B (financial offer). Bids submitted without all the asked documents and signing of Annexes 01, 02, 03, may not be considered for further evaluation. Please also note that sub-standard uncertified equipment or equipment with incomplete specifications will be rejected.
3. Sealed tenders must be submitted by January 12<sup>th</sup> 2022, at 5 p.m. **at Cesvi Lebanon Office** [Furn el Chebbak, Chiyah area, facing Notre Dame de Lourdes church, Pritzke building 2nd floor above Amel association CDC], Beirut and should be marked as "Not to be opened before January 13<sup>th</sup> 2022". Please note that the deadline might be extended in case of security circumstances or any force majeure.
4. Electronic bidding is **NOT ALLOWED**, failure to take heed will automatically get a disqualification.
5. Tenders opening session will be held in **Cesvi Lebanon Office** [Furn el Chebbak, Chiyah area, facing Notre Dame de Lourdes church, Pritzke building 2nd floor above Amel association CDC, Beirut] on January 13<sup>th</sup> 2022, in the presence of bidder's representatives (only one representative from each bidder), who wish to witness the tender opening. If the bidder is willing to attend the opening session, he should communicate by e-mail his intention (by writing to [logistics.libano@cesvioverseas.org](mailto:logistics.libano@cesvioverseas.org).) – in order Cesvi to avoid overcrowded situations.
6. Tender evaluation sessions will be held starting from January 13<sup>th</sup> 2022 behind closed doors.
7. Tender Committee reserves the right to increase/decrease the quantity of supplies by maximum 20% after award of tender to the tender winner.
8. Bidder must not be engaged in any corruption, fraudulent, collusive or coercive practices including but not limited to applying/bidding by multiple names/companies or submitting a fake call deposit/earnest money. Bidders also have to declare that they are a "**Not Blacklisted**" firm/company by any reputable organization in Lebanon. A written signed declaration will be required from the selected bidders, followed by accurate check to be carried out by Cesvi. If any bidder is found to be involved in such practices, their bid will be rejected and the companies in question will be permanently blacklisted.
9. Lowest price will not be the sole criteria of selection. **Delivery time, verifiable relevant previous experience with other INGO/NGOs, the quality of the items, quality and certificates to be provided** will also be considered in the selection of bids.
10. Tender Committee reserves the right to cancel/reject any or all bids/offers without assigning any reason.
