- Detailed specifications
- Country of manufacture of each item
- The earliest possible delivery date and shipping time
- Defects, liability and guaranty period
- Total price listed by place of delivery.
- The name of the freight forwarder which the cost of delivery has been based on. (DAP / FOB only)
- Type of packing,
- Estimated net and gross weights, and total volume for offered items.

## **Pertinent information:**

- Dispatch after the agreed schedule of shipment may be subject to deduction from the invoice of 1% per started week of the total EX Works value of the contract, except from force majeure: Unforeseen war, strikes etc.
