#### **General information**

a. Brief information on the project

The Deutsche Gesellschaft für Internationale Zusammenarbeit (giz) GmbH is a federal enterprise commissioned by the German Federal Ministry for Economic Cooperation and Development (BMZ).

c. The contractor shall provide the following work/service:

#### The supplier shall provide and deliver the below items:

- Moderation cases with the following Specifications:

 Option 1: Nylon, black, padded front pocket with elastic band and zipper, padded side pockets, padded zipper pocket on the back, padded and adjustable backpack straps, handle W 40 x D 25.5 x H 47 cm (or approx.)

2. Option 2: Aluminum design case with 2 wheels and extendable handle on aluminum rails. Material: aluminum. Size: 54 x 35 x 16 cm (W x H x D) or approx.

The contents of the moderation cases is minimum as per the below:

- 1 Push Pin Box.
- 500 Rectangular Cardboard Sheets (Weight of 130 g/m² or similar & Dimensions 9,5 x 20,5 cm or approx.) assorted colors.
- 250 Oval Cardboard Sheets (Weight 130 g/m² or similar & Dimensions 11 x 19 cm or approx.) assorted colors.
- 250 Small Round Cardboard Sheets (Weight 130 g/m² or similar & Diameter: 9,5 cm or approx.) assorted colors.
- 1,000 Marking Dots assorted colors.
- 4 Large Markers (Black, Red, Blue, Green).
- 10 Large Black Markers.
- 1 Glue Stick.
- 1 Roll of Crepe Tape.
- 1 Cutter with 2 Spare Blades.

#### Each item should be separated and organized in the moderation case.

- Foldable pinboard with the following Specifications:
- Extendable legs & hinged swivel feet or similar.
- · Carrying handle with locking strap.
- Aluminum frame.
- Overall Dimensions 126.5 x 193 cm or approx.
- Work Surface 118.5 x 146 cm or approx.
- Transport Dimensions 126.5 x 81 cm or approx.
- Work Surface: Cardboard rigid foam board or felt-cloth-laminated rigid foam board.
  - Carrying bag for foldable pinboard with the following Specifications:
- Shoulder strap, front pocket, carrying handle, zipper.
- Material: Polyester
- · Color: Black.
- Fits 1 foldable pinboard (without castors) or 1 transportable flipchart.
- Dimensions: W 128 x H 82 x D 7.5 cm or appox.

### **Tender requirements**

#### 1. Qualification of the proposed supplier

The supplier must comply with the below requirements:

• The supplier must have an official registration and MoF registration in Lebanon (minimum requirement)

- The supplier should provide the catalogue of all the requested items with pictures (minimum requirement)
- The supplier should prove that the items are not supplied from RUSSIA OR BELARUS
- The supplier should be able to deliver the order to GIZ Office in Hazmieh (minimum requirement)

#### 2. Requirements on the format of the tender

#### 1. Technical Proposals consists of:

- Technical proposal shall be sent as PDF file including the complete and detailed description of the items as per the inquiry.
- Technical proposal shall be signed, dated, and stamped.
- Company's Portfolio or background.
- Company's legal documents, company registration and MoF registration.
- GIZ general purchase conditions signed, dated, and stamped.
- Self-declaration EU-Russia sanctions signed, dated, and stamped.
- Kindly note that any price indication of any item in the technical offer may lead to disqualification.
- Mention the delivery Date

#### 2. Financial Proposals, which should consist of:

- Financial proposal in USD including Taxes/VAT.
- Financial proposal includes the date and the company's Tax registration number at the Ministry of Finance.
- Financial proposal shall clearly indicate the price of the overall tender and the price for each of each item.
- Bank account details of the company inside Lebanon.

#### Others:

- Please note that in case you did not receive any notification in writing within 4 weeks after the deadline for submitting the offers, it shall indicate that your offer has not been accepted. You shall not receive a separate notice to this effect.
- The bidders shall not be reimbursed for their submitted offers.
- Sending your offers to any other email address or non-compliance with any of the mentioned conditions will result in rejecting your participation in this tender.
- All Products / items with Origin Russia or Belarus are not accepted by GIZ Office and Project due to sanction list against Russia and Belarus.
