### Subaward Financial Management Manual - Form 8.3A

<b>Instructions:</b>		
Form is completed by the organization that is expected to receive a subaward from Mercy Corps. Required for all subawards. To be completed by the <b>legal entity that will hold legal responsibility for the subaward</b> (the organization that will be named in the subaward. If a parent organization's locally registered affiliate or subsidiary (a legally separate entity) will implement the subaward activities, complete a separate form for that organization.

<b>9</b>	Is the organization legally registered in the country where the subaward activities will be implemented? If this is a different registration than in 8 above, attach a copy of the registration.	
<b>10</b>	Organization's government tax ID number ( <i>required unless tax ID number is not provided by the government</i> )	
<b>11</b>	Does the organization have a bank account in the organization's name? If yes, please also provide the bank name.	
<b>12</b>	What are the beginning and end dates of organization's fiscal year? (e.g. Jan-Dec; Jul-Jun, etc.)	
<b>13</b>	Is the organization exempt from paying VAT or other taxes? If yes, provide a copy of the organization's tax exemption document	
<b>14</b>	Organization's DUNs number ( <i>required when subaward is funded under a <b>US government award</b> and subaward estimated amount is USD 25,000 or more</i> )	
<b>15</b>	Organization's PADOR number ( <i>required when subaward is funded under a <b>European Union (EU) award</b></i> )	

16	Is the organization requesting reimbursement for indirect costs under the subaward? If yes, attach the organization's policy that requires costs to be consistently charged as either indirect or direct.	
<i>Note: Mercy Corps does not allow indirect costs as a part of the subaward budget, except when: 1) the organization has a policy on charging costs as direct or indirect, and it can be verified from the financial records that this policy is followed consistently; AND such indirect costs either: meet all the donor's requirements for indirect costs; or the specific indirect cost rate for the organization is approved in advance by donor.</i>
