

TENDER INVITATION

You are kindly invited to tender for the work of "Rashet Kheir PV System Supply & Installation" as defined in the following Contract Documents attached to this email-invitation:

- 1. Bills of Quantities
- 2. Drawings (Architectural to support the take-off quantities)
- 3. Pictures of the site

Which shall be deemed to be binding upon the Contractor and in full force and effect as if written in whole in this contract.

- 1. Tender must be delivered by hand to Rashet Kheir Purchasing Office; Attention Mrs. Ilda Nahas not later than <u>Saturday February 25, 2022 between 10:00 AM and 13:00 PM</u> in a sealed envelope bearing the name of the bidder and plainly marked TENDER for "Rashet Kheir PV System Supply & Installation".
- 2. Tender must be submitted on the attached Forms completely filled in, Bidders shall bid Lump Sum, and in addition shall bid a "Unit Price" for each and every item listed in the Bill of Quantities. Bidders shall return, duly completed and signed all documents and drawings accompanying this invitation. The Tender shall remain valid for a period of 30 days and shall constitute a binding agreement if and when accepted in writing by Rashet Kheir. A soft copy of the Bill of Quantities, in the provided Excel format should be submitted with the bid.
- 3. Rashet Kheir reserves the right to reject any or all Tenders or select a Tender other than the lowest. It is also understood and agreed that Rashet Kheir will not be asked, under any circumstances, to reimburse the costs of preparing the Tender and/or to pay any indemnity whatsoever in case the Tender is refused.
- 4. Rashet Kheir reserves the right to delete any of the items in the Bill of Quantities.
- 5. All questions for clarifications of the documents will be addressed by email to info@rashetkheir.org and before February 21, 2022. Answers will then be distributed to all bidders. A site visit can be conducted upon the request of the bidder. Access to site will be granted and fixed by Rashet Kheir after receiving an email from the bidders who will confirm participation & requesting the visit no later than February 22nd, 2022.



- 6. All Tenderers shall have to submit the following documents with their tenders: (Failure to do so for any item may disqualify the offer):
- Priced RK Bill of Quantities
- Technical data sheets for the materials that will be used (PV panels, Inverters, Batteries, Cables, epoxy, TOT corrugated sheets, etc.) and the corresponding suppliers (Appendix B)
- Method Statement for concrete and steel reinforcement repair if and where needed (Appendix C). The price of the concrete repair and reinforcement should be included in the Lump Sum price of the steel structure
- A bar chart construction program with a minimum of six activities (Appendix D)
- The resume of their Project Engineer (Appendix E)
- Company profile (Appendix F)
- Company commercial register (Appendix G)
- A list and photos of similar projects (Appendix G)
- 7. After the award of the contract, the Contractor shall provide an un-cancelable all risk insurance policy covering works carried out on and /or for Rashet Kheir.
- Third party Liability insurance against any accident that may occur during the works for a maximum amount of \$30,000 USD.
- The Contractor should insure all his workers against accidents.
- 8. The bidder shall price as per all the requirements of the bid documents. This shall be considered as the Basic Bid. In case of any deviation from the above, the bidder shall first price in accordance with the Basic Bid, then propose an alternative. Alternative Bids will only be considered if the bidder has submitted a Basic Bid.
