It manages a network of 40 projects serving the most vulnerable populations, across the Lebanese territory including Community Health Centers (following the MoPH Primary Healthcare Program), Mobile Medical Units, Elderly Day Care Centers, Hosting Centers for the Differently Abled persons and projects for the displaced and refugees.
