## **Composition of Quote:**

Bidders shall submit quotes for items detailed in Appendix B. The quote will consist of Appendix A through C (see above).

Quoted prices must be in USD, <u>exclusive</u> of VAT and should include a breakdown of the price: base price per item, transportation fees per location, any other fees.

#### SECTION 1 – QUOTATION INSTRUCTIONS / ADDITIONAL INFORMATION

The Bidder shall submit its best price offer/quotation as per the following requirements:

- Quotation Cover Letter signed by a person authorized to sign on behalf of the Bidder. Use the template in Appendix A.
- 2. Bidder shall submit quotes based on the description and specifications in Appendix B
- 3. In case of price discrepancy between unit price and TOTAL price, the unit price shall prevail.
- 4. Payment term: Net 30 days.
- 5. Bid validity: Net 60 days from the date of submission.
- 6. Bidders must meet the following criteria:
  - Valid business License (Commercial Register Certificate)
  - Tax Identification number details (Tax registration Certificate)
  - VAT registration certificate
  - Contact person, telephone, and e-mail.



#### SECTION 2 – DESCRIPTION OF GOODS/EQUIPMENT REQUESTED

### **SECTION 3 – SPECIAL PROVISIONS**

#### 3.1 Source and Nationality

This RFQ will be financed by USAID funding and will be subject to U.S. Government and USAID regulations. The authorized USAID geographic code for this RFQ is Code 937. Code 937 is defined as any area or country including the recipient country but excluding any country that is a prohibited source. A list of developing countries, advanced developing countries, and prohibited sources is available in USAID's Automated Directives System, ADS 310 <a href="http://www.usaid.gov/policy/ads/300/310.pdf">http://www.usaid.gov/policy/ads/300/310.pdf</a>.

The following applies to this RFQ, all related correspondence, and any resulting contract:

#### A. Definition

- i. Cooperating Country: "Cooperating country" means Lebanon.
- ii. **Source:** "Source" means the country from which a commodity is shipped to the cooperating country or the cooperating country itself if the commodity is located therein at the time of purchase. However, where a commodity is shipped from a free port or bonded warehouse in the form in which received therein, "source" means the country from which the commodity was shipped to the free port or bonded warehouse.
- iii. **Nationality**: "Nationality" refers to the place of incorporation, ownership, citizenship, residence, etc. of suppliers of this good and must fall under the 937 code.

## 3.2 Inspection

DAWERR shall have reasonable time to inspect the goods/equipment provided, anytime during the performance period of the PO as well as after delivery, and to reject acceptance if not conforming to the specifications of the PO and offer. Recovery of the rejected item (s) shall be the sole responsibility of the Bidder.

### 3.3 Warranty

Warranty service and repair is required for the Fixed Weighbridge Scale under this RFQ. The warranty shall cover all equipment, works, manpower, spare parts, replacements, resulting from failure of equipment, systems and accessories supplied by the selected bidder, except when said failures are due to the Client's fault. Bidders shall describe their warranty and what is covered. Warranty is included as one of the evaluation criteria in Section 4 below.



## 3.4 Training

Selected bidder(s) must send a technician to conduct a demonstration and training on how to use the Fixed Weighbridge Scale for workers responsible for operating the supplied equipment in the composting facility in the below mentioned locations and to provide guidance booklets and instruction manuals for the supplied equipment.

#### **SECTION 4 – EVALUATION CRITERIA**

All quotations received in response to this RFQ will be evaluated by DAWERR. The Purchase Order shall be awarded based on the best value to the DAWERR.

## DESCRIPTION AND SPECIFICATIONS OF GOODS/EQUIPMENT

## **BACKGROUND**

On June 30, 2020, USAID/Lebanon awarded ECODIT the Diverting Waste by Encouraging Reuse and Recycling (DAWERR) Activity, a five-year project that will establish sustainable and replicable integrated solid waste diversion and valorization solutions in rural areas of Lebanon, leading to improved social and economic well-being for Lebanon's population.

During the first three years of the Activity, DAWERR worked with four municipalities -Baskinta, Jezzine, Rachaya el Wadi and Qaraoun- and supported them in the development of solid waste management (SWM) solutions at the individual/municipal level. In addition to the Phase 1 municipalities, DAWERR started supporting three Phase 2 Clusters of municipalities including:

- 1. Anfeh  $(host)^1$ , Bechmezzine, Kfarhazir and Fih, in the Koura District
- 2. Ras el-Matn (host), Qortada and Deir el-Harf, in the Baadba District
- 3. Ansariyyeh (host), Sarafand Loubieh, and Saksakiyyeh, in the Saida District

DAWERR is supporting Phase 1 and Phase 2 municipalities to implement SWM solutions including the construction of composting stations and provision of needed equipment.

As part of this RFQ, DAWERR is requesting quotes from eligible offerors to provide, deliver and install one fixed weighbridge scale to each of Anfeh, Ansariyeh and Ras El Metn municipalities (total quantity of weighbridge scale needed is three) – see below coordinates for potential delivery location, as well main features and specifications of the weighbridge scale.
