1. Introduction about Restart center:

Restart Center for the Rehabilitation of Victims of Violence, Torture is a Non-Governmental Organization (NGO) active in the field of Human Rights; specifically, the Rights to Rehabilitation and Prevention from Torture.

As of 1996 till date, Restart Center has been ensuring effective identification and access to rehabilitation for all victims of torture and ill-treatment throughout the provision of health, psychological, social and physical rehabilitation as well as legal services to victims of Torture, War Trauma and their families.

The provision of Psychotropics, Narcotics and other General health drugs forms a major part of our services.

2. Background:

In view of the above, Restart center intends to launch a tender for the provision of medicines and another one for the establishment of a frame agreement for 3 years period

The purpose of this EOI is to assess the market and avail capacity of suppliers to deliver the items as per Restart center requirements, prior to launching a formal public tender. The items listed in Annex A represent an indication and may vary by the time of tender launch.

We would appreciate taking the time to complete the below requirements for pre-qualification if you are interested in taking part of the upcoming bidding process.

3. Description of Requirement:

- 3.1 Restart is seeking Expressions of Interest for the supply of Medicines in Lebanon, the delivery shall be mainly to the below listed areas, but not limited to:
 - a. Tripoli
 - b. Beirut
- 3.2 Attached you will find for your information, not binding, an indicative list of items to be supplied under Annex A– Technical Specifications –Medicines.



3.2 This EOI does not constitute a solicitation. Restart reserves the right to change or cancel the requirement at any time during or after the EOI. Restart also reserves the right to require compliance with additional conditions as and when issuing a formal solicitation. Submitting a reply to the EOI does not necessarily guarantee participation in the solicitation when issued.

5. General Instructions

Please note that Restart Center is committed to ensuring fairness in the selection process. Prequalification will be based on your company meeting Restart expectations for the medicines to be supplied.

- ➤ This invitation of application for pre-qualification is open to potential applicants who are able to demonstrate proven technical, financial and managerial capacity to supply medicines.
- ➤ Restart center reserves the right to request the submission of additional information from applicants or any other credible source, and to visit and inspect the business premises of the applicant to verify the information given.
- Restart center will ensure information that is received from companies is treated with the utmost confidentiality and shall be for the sole use of the organization.
- ➤ The pre-qualified suppliers are required to immediately advise the organization of any significant change in its financial, technical capacity, ownership or holdings it may have.
- Failure to submit any of the mandatory requirements might lead to disqualification from the exercise.



Restart might conduct a verification visit to prospective suppliers to assess their capability prior the selection process. Warehouse visit will be part of the verification visit.

 - VAT registration
 - o License to sell medicines in Lebanon from Ministry of Public Health (MOPH)
 - Financial standing: Provide certificate of non-bankruptcy and no judicial liquidation in addition to copies of the company's audited accounts for the last three (3) years
 - Valid Good Storage and Distribution Practice (GSDP) certification
 - o Valid Good Manufacturing Process certifications for manufacturers (GMF)
 - List of warehouse location and capacity and delivery coverage in Lebanon
 - Confirmation on Companies capacity for weekly delivery to Beirut and Tripoli
- Technical specifications of products provide confirmation in EOI about the item coverage and the list of certification/documentation available for each item in Annex A.
