• Validity of Quotes

Quotes submitted shall remain open for acceptance for **one month** at least from the last date specified for receipt of quotes. The selected Bidder(s) shall supply the amounts of goods requested at the quoted prices for the delivery/performance period specified in this RFQ.

• Eligibility Criteria

Interested vendors are invited to submit quotations in response to this Request for Quotation (RFQ). To be eligible, vendors must meet the following criteria:

- Legal Compliance: Vendors must be registered in MoF and the VAT department. Proof of legal compliance is required.
- **Experience:** Vendors must have a proven track record of successfully delivering similar products for at least 2 years. Proof of experience is required.
- **Quotation Submission Requirements:** Vendors must ensure that all required documentation, including completed quotation forms and any additional requested information, is submitted by the specified deadline.
- **Products' sample:** Vendors must attach to their quotation a catalogue that includes the pictures and specifications of the items specified in page 4 and 5.

Failure to meet these eligibility criteria may result in the rejection of the quotation. The evaluation of quotations will be based on a fair and transparent assessment of the information provided by each vendor. Any inquiries regarding eligibility or the RFQ process should be directed to the procurement department at procurement@theforum-lb.org no later than January 16, 2024 COB.

Basis of Selection

Bidders should provide their most competitive quotes. All Bidders will be notified in writing should there be a significant change to the listed requirements. A Long Term Agreement will be issued to the responsible Bidder that is judged to be most advantageous to FRPD in terms of price, quality, delivery time, warranty offered and previous similar experience in implementing similar projects. FRPD may accept any item or group of items of a bid. FRPD reserves the right to make an award on any item for a quantity less than the quantity stated, at the unit prices quoted.

FRPD may reject any quote that is determined to be non-responsive. A responsive quote is one that complies with all terms and conditions of the RFQ. A quote must be complete, signed by an authorized signatory, and delivered by the submission time and date indicated on the first page of this RFQ. FRPD may reserve the right to waive any minor discrepancies in a quote.

This RFQ does not legally obligate FRPD to award a contract. FRPD reserves the right to fund/award any or none of the submitted quotes. No commitment is made, either expressed or implied, to compensate Bidders for costs incurred in the preparation and submission of their quotes.
