1. REQUIREMENTS

Restart Center for Rehabilitation of Victims of Violence and Torture invites qualified Vendors to make a firm offer for the establishment of Frame Agreement(s) for the provision of Car Rental Services.

Restart Center may award Frame Agreement(s) with initial duration of one year, potentially extendable for a total of 2 (two) years period, 1 (year) each extension, subject to the satisfactory vendor's performance and availability of funds. The successful bidders will be requested to maintain their quoted price for the duration of the Agreement.

Restart Center will compile the questions received and plan to respond to the questions shortly after the query closing date.

Restart Center may, at its discretion, copy any reply to a particular question to all other invited bidders at once.

4. **YOUR OFFER:**

Your offer shall be printed in <u>English</u>. if the offer is hand written it should be prepared using **BLUE INK PEN**

Your offer shall comprise the following two sets of documents in two different sealed envelopes:

- Technical offer- Annex A
- Financial offer-Annex B

Technical and financial offer must be sealed and stamped in TWO SEPERATE envelopes which then should be sealed and stamped in a third envelope. Offers not following this requirement may be disqualified.

Please submit your offer using the Annexes provided. Offers not conforming to the requested formats may be not taken into consideration.

IMPORTANT:

Please send your bid directly to the address of Restart Center provided in the "Submission of Bid" section 8 of this ITB.

5. Content of the TECHNICAL OFFER:

IMPORTANT:

No pricing information should be included in the Technical offer. Failure to comply may risk disqualification. The technical offer should contain all information required.

Your technical offer should clearly state whether or not the Cars required are conforming to the specifications given. Clearly state and disclose any discrepancies with the specifications given.

The following details shall also be provided in the Technical Offer.



PART 1

Technical requirements ANNEX A:

- Items availability: The technical offer shall clearly indicate the vehicle quoted for in your offer (Annex A).
- Time required for delivery after confirmation of Order: The suppliers are advised to provide a time frame required for delivering the Vehicle Annex A. Cars should be immediately ready to be provided to Restart center or within maximum of 1 week.
- Dual Airbags should be available.
- Location of maintenance garage: The Location of maintenance garage should preferably be in Tripoli or close to Tripoli or provide Mobile maintenance services free of charge.
- Vehicles brand name: The technical offer shall state all the vehicles brand names.
- Insurance Coverage: All risk insurance coverage without Liability.
- Supplier should confirm responsibility for Motor Vehicle Formal Inspection (Mecanique) and car maintenance. (Annex A).
- Supplier should indicate the Period of provision of replacement car in case of damage or maintenance of car provided in days. (Annex A). Restart's maximum timeframe accepted is 3 days.
- Additional information: Any information which the supplier may consider necessary or useful to clarify their bid is appreciated.
- Vendor Registration Form: If your company is not already registered with Restart, you should complete and submit with your technical proposal the Vendor Registration Form (Annex C)

PART 2

Supplier documentation and certification

Vendor information: Supplier should provide registration documents.

- Ministry of Finance Registration
- VAT Registration
- Financial standing: Provide certificate of non-bankruptcy and no judicial liquidation



6. Content of the FINANCIAL OFFERS:

Your separate **Financial Offers** must contain overall offers in a single currency, in **US Dollar.** Bids that have a different price structure may not be accepted.

Unit costs: the bidder shall quote the unit price (per vehicle separately) and discounts shall be clearly indicated.

Format: Use ONLY the attached Annexes B.1 (Price list) for submitting your quote.

- 1. You are requested to hold your offer valid for 90 days from the deadline for submission. Restart will make its best effort to select a company within this period. The pricing model quoted in the Supplier's offer will remain valid for the duration of the Frame Agreement. Restart's standard payment terms are within 10 days after satisfactory implementation and receipt of documents in order_on a monthly <u>basis</u>.
- 2. Restart will not be responsible for any maintenance costs like oil, filters, break pad changes etc. Therefore, the financial offer must be inclusive of all regular maintenance costs.

 All vehicles must be insured under a valid obligatory third party insurance and All Risk insurance. Restart will not be responsible for any liability.

7. **BID EVALUATION:**

The evaluation will be conducted in 2 stages as follows:

- First Stage (Technical): Restart nominated technical evaluation committee will conduct the technical evaluation of the received offers, based on a pass/fail determination as listed in section 5, and whether the specification substantially conform to the request.
- ➤ <u>Second Stage (Financial)</u>: Bids will be tabulated and compared for all companies passing the technical evaluation. It is important to send a complete and detailed offer. The contract may be awarded to the vendor(s) with the lowest technically compliant offer.

IMPORTANT: The Financial offers will only be opened for evaluation if the supplier's technical part of the offer has passed the technical evaluation and has been accepted by Restart Center as meeting the technical specifications.



8. SUBMISSION OF BID:

9. **BID ACCEPTANCE**:

Restart reserves the right to accept the whole or part of your bid.

Restart may at its discretion increase or decrease the proposed content when awarding the contract and would not expect a significant variation of the rate submitted. Any such increase or decrease in the contract duration would be negotiated with the successful bidder.

Please note that Restart is not bound to select any of the firms submitting bids and does not bind itself in any way to select the firm offering the lowest price. Furthermore, the contract will be awarded to the bid considered most responsive to the needs, as well as conforming to Restart's general principles, including economy and efficiency and best value for money.

Restart may, at its discretion, extend the deadline for the submission of bids, by notifying all prospective suppliers in writing. Such extension of the deadline may accompany a modification of the solicitation documents prepared by Restart at its own initiative or in response to a clarification requested by a prospective supplier.

10. CURRENCY AND PAYMENT TERMS FOR THE CONTRACT:

Any agreement or contract revealed as a result of this ITB will be made in the currency of the winning offer. The contract/agreement will be in US Dollar as offers and Invoicing should be in USD. Payment will be done in accordance with the currency specified in the agreement.

10.1 PAYMENT TERMS

Bank commission amounting to 7% shall be deducted from the total invoice in case of payment through a cash payment letter.

Full amount of the invoice is transferred to your account without bank commission deduction in case your company possess a fresh account at Byblos Bank.

Bank other than Byblos: Bank commission varying from 15\$ to 30\$ shall me deducted from the total invoice in case of payment through an outgoing bank transfer (This total excludes the bank commissions deducted on the transfer from your bank

11. ZERO TOLERANCE POLICY:
