All questions during the tender period, as well as the associated answers, will be shared with all invited bidders after the Deadline for Queries(date)

- **1. Delivery time:** the bidder shall state the delivery lead time from the same exact date the coupon is received. Shorter delivery time will be given higher consideration.
- 2. **Delivery terms:** Delivery at place (DAP) Tenderer(s) shall be responsible for all costs arising from packing, forwarding and delivering of goods to actual points of delivery including loading, unloading, transport. The prices should include the transportation cost (the location will be determined by the beneficiary upon purchase/within Beirut)
- **3.** Warranty for the supplied items: The supplier must check/inspect the items before dispatching them to the beneficiaries, and in case of rejected items, they must be replaced by the supplier at no cost. please state the warranty period Longer period of warranty will be considered as an added value.

4. SAFETY:

Covid-19 preventive measures **must be** implemented and respected at all times. The bidders take full responsibility to apply all the WHO recommended precautions before and during packaging, and through the delivery of the items. Such measures include PPE protective gear for the respective staff (warehouse, drivers, porters, etc./), as well as regular sanitization of the packaging space, the handling equipment, and the trucks

- In case of payment in LBP, the value of the Lebanese Pound shall be determined according to the exchange of the US dollar issued by the Beirut Stock Exchange, on the payment's date.

To be technically acceptable, the bid shall meet or exceed the stipulated requirements and specifications in the ITB.

A Bid is deemed to meet the criteria if it confirms that it meets all mandatory conditions, procedures and specifications in the ITB without substantially departing from or attaching restrictions with them. If a Bid does not technically comply with the ITB, it will be rejected.

All bids that pass the Technical Evaluation will proceed to the Financial Evaluation. Bids that are deemed technically noncompliant will not be financially evaluated.




