1. Introduction

As part of Youth Resolve II Project, GAME will work on building communities' resilience and strengthening social stability through Street-Sports and for the first time in Lebanon, through Street Sports Incubator.

Youth Resolve II is the continuation of a project funded by the European Union, through the European Union's Regional Trust Fund, the "EU MADAD" fund, and carried out by World Vision, UTOPIA, DPNA and GAME. The goal of the consortium is to empower youth by providing them with the tools to become leading actors in their communities.

2. Confidentiality

GAME will treat the content of all tenders/quotations as being confidential and information provided in the tenders will be used for the purpose of deciding on the award of a contract as described in this document.

After the interviews, GAME procurement committee will offer the contract to the best applicant and offer.

11. Evaluation Criteria

The evaluation of the technical bids, submitted by consultants/consultancy firms, would be conducted according to the following criteria: Professional Experience, Experience in conducting web platforms and mobile apps, educational qualifications, experience in Lebanon and quality of technical proposal. The analysis of the technical bids is 75% and the financial bids will constitute the 25% left.
