ABOUT MARCH LEBANON

MARCH is a Lebanese non-profit non-governmental, non-profit organization founded in 2011 (Registration Number 956) working to consolidate social cohesion within some of the country's most prominent volatile areas. ABOUT THE PROJECT

As part of its youth led community service initiatives, March is seeking for supplier who can provide us with essential necessity boxes (Basic Needs). These boxes are intended for distribution among the most vulnerable families who are facing critical needs.

We are requesting quotations for a Supply of 4 500 Box of Basic Needs Parcels

These items will be delivered to the March Office in Tripoli: Kahwetna, Syria Street, Beb el Tebbeneh.

Please read the following before submitting the tender:

1. Quantity is subject a change.

2. Issuance of Payment occurs within 15 days after delivery and submission of legal invoice by bank transfer in fresh dollars.

3. Bank charges if/when cash is withdrawn from the supplier's account are at the supplier's expense.

4. If/When Prices include VAT, it must be shown on the invoice.

5. Bidders offering a competitive price with require Items for the Basic Needs tender are required to submit a sample prior to final selection.

6. NO other form is accepted only this form must be filled with the prices and Annexes, signed and stamped by the supplier.

7. Suppliers must abide by the specified quantities and description of each item (different options are not accepted).

8. Every supplier has to fill the registration form (Annex A), quotation submission for Kit 1 (Annex B), &Delivery time (Annex C), and legal papers (company registration & Tax number), and place them in a closed envelope. Sign and stamp the envelope and submit it by hand to March Lebanon Offices. Any missing document, and the submission will be cancelled.

9. Invoice must be official and legal.
