## 1. SUBMISSION OF BID

You must submit one original of the RFT Bid Form in a sealed envelope, clearly marked with the RFT number and the Bidders name.

The sealed envelope must be deposited into the PLACEMAKING M.E. REGION Tender Box at the address stated on page one before the RFT Closing Date and Time. It is the Bidders responsibility to ensure that the sealed envelope is deposited into the Tender Box.

Any Bids not received on the official PLACEMAKING M.E. REGION Bid Form, or in a sealed envelope may be disqualified for non-compliance with these RFT Instructions.

All Bids received in pencil will be disqualified.

# 2. PRICES

All Bids must include all customs and taxes payable in the country of delivery unless the RFT specifically requests a Bid is other than DDP.

All Bids must be in the currency stated on the RFT Bid Form. Bids in any other currency may be disqualified.











PLACEMAKING M.E. REGION reserves the right to correct any incorrect calculations on the Bid Form.

### 3. VALIDITY OFFER

Your Bid must be valid for the 'Bid Validity Period' as stated on the Bid Form. Bids not meeting the Bid Validity Period may be disqualified.

PLACEMAKING M.E. REGION will attempt to notify all suppliers of the outcome of their Quotations by **16**<sup>th</sup> **of November 2020**.

### 4. EVALUATION OF BID

All Bids received and accepted will be evaluated on a 'line item' basis as follows:

- a. <u>Administrative Evaluation:</u> Evaluated to ensure compliance with all the RFT requirements and to ensure that all Bids and calculations are readable and acceptable.
- b. <u>Technical Evaluation</u>: All Bids received will undergo a Technical Evaluation based on 'best value for money'. Bids that comply with the requested items, specifications, and delivery conditions will be classed as 'responsive' (acceptable). Only Bids classed as 'responsive' (acceptable) will progress onto the 'Financial Evaluation'. 'Non-responsive' bids (not-acceptable Bids) will no longer be under consideration at this stage.
- c. Financial Evaluation: All 'Responsive' Bids will undergo a Financial Evaluation

# 5. CONTRACT AWARD

Under the 'best value for money' principle, PLACEMAKING M.E. REGION will award the contract(s) (PLACEMAKING M.E. REGION Purchase Order or Service Contract) to the 'lowest responsive bid' except where other considerations are warranted.
