26. **Evaluation Criteria:** The Evaluation Criteria consists of 3 phases:

1st Phase: Legibility of suppliers

• A supplier will be considered legible for this tender by providing the

documents and information request in the paragraph "Submissions of

Offer - 22.2".

• Eligible suppliers will be excluded, and legible suppliers will be considered for the 2nd phase.

2nd Phase: Technical Evaluation

- Quoted medicines must be registered at "Lebanon National Drugs database"
- Medicines that are not registered at "Lebanon National Drugs database will be rejected
- Each medicine will be evaluated separately
- Technically accepted medicines will be considered for the 3rd phase.

3rd Phase: Financial Evaluation

- Only legible suppliers (1st phase) and technically accepted product/item (2nd phase) will be considered for the 3rd phase.
- Lowest submitted price will be selected.
- Each product/item will be rewarded separately

Some other factors will be considered in the rewarding process such as: delivery period, payment terms, warranty, etc...
