1. Who is the Danish Refugee Council?

Founded in 1956, the Danish Refugee Council (DRC) is a leading international NGO and one of the few with a specific expertise in forced displacement. Active in 40 countries with 9,000 employees and supported by 7,500 volunteers, DRC protects, advocates, and builds sustainable futures for refugees and other displacement affected people and communities. DRC works during displacement at all stages: In the acute crisis, in displacement, when settling and integrating in a new place, or upon return. DRC provides protection and life-saving humanitarian assistance; supports displaced persons in becoming self-reliant and included into hosting societies; and works with civil society and responsible authorities to promote protection of rights and peaceful coexistence.

Operating since 2004 in Lebanon, DRC has addressed the needs and rights of vulnerable populations, working initially with Palestinian refugees (since 2004), Iraqi refugees (2007-2010), Lebanese IDPs (during the 2006 conflict), migrant domestic workers (since 2009), responding to the Syrian refugee crisis (since 2011) and to Lebanese crisis (since 2019).

DRC Lebanon is currently delivering programming in protection, livelihoods, and community development interventions. This myriad programming seeks to address the immediate needs of displaced populations and concurrently support vulnerable host populations. DRC has four offices spread throughout Lebanon in, Beirut, the Bekaa and North (Tripoli and Akkar).

2. Purpose of the consultancy

The Danish Refugee Council based in *Lebanon* seeks to sign a long term contract with a local/international insurance company that supports coverages to different policies such as below:

- Group Life & Personal Accidents
- Workmen Insurance

However, the purpose and objective of this ToR is to hire a temporary consultant to support in the technicalities of the tender that will be published beginning February to select a best fit medical company meeting DRC's requirements, and mainly focus on the below deliverables.

3. Deliverables

The Consultant will submit the following deliverables as mentioned below:

A summary per bidder will be provided by the consultant tackling the technical part only that compares the received bids versus DRC's requirement.	3 working days

The Consultant will provide the documentation by email including all excel, powerpoint, word, and PDF documents

4. Duration, timeline, and payment

The total expected duration to complete the assignment will be **no more than 6 working days in total.**

5. Qualification, and experience required

Essential:

- 3-4 years of experience in the insurance sector in Lebanon.
- Advanced understanding of different insurance coverages, limits and exclusions.
- Knowledge of the Lebanese insurance markets, and leading Insurance networks spread and henefits
- Ability to provide fair technical inputs to different insurance companies applying for same request.
- Advanced understanding in the current insurance challenges in Lebanon when it comes to reimbursements, staff insurance coverages and limits per coverage.
- Advanced understanding of the Lebanese legal decrees for the abovementioned deliverables to be in-line with the local laws and a same time attain the best benefits.

Language requirements:

- Written Full proficiency in spoken and written English and Arabic.

The service provider is required to submit a Financial Proposal in <u>separate email "Annex A. Financial Proposal"</u>.

- The Financial Proposal must provide a detailed cost breakdown in USD including consultant's rate budget allowance, time and material, etc.
- > Bidders must submit an overall firm-fixed price bid in USD.
- Invoicing and payment will be performed by Bank transfer in fresh USD.
- All costs will be fixed.

Only those shortlisted will be contacted for an interview with the panel to ensure their understanding of the consultancy services.
