### 3- Payment terms and conditions:

Any Agreement or contract revealed as a result of this RFQ will be made in the currency of the winning offer. The contract/agreement will be in US Dollar as offers and Invoicing should be in USD. Restart's standard payment terms are within 7 days after delivery of each PO via Bank letter or Bank transfer.

- Bank commission amounting to 10% shall be deducted from the total Invoice in case of payment through a cash payment letter.
- Full amount of the invoice is transferred to your account without bank commission deduction in case your company possesses a fresh account at Byblos Bank.
- Bank other than Byblos: Bank commission varying from 15\$ to 30\$ shall be deducted from the total invoice in case of payment through an outgoing bank transfer. (This total excludes the bank commissions deducted on the transfer from your bank).
