## **Section 1: Instructions to Offerors**

1. **Introduction:** Chemonics, through Chemonics Beirut S.A.R.L., acting on behalf of the U.S. Agency for International Development (USAID) and the Lebanon Enterprise Development (LED) Project, under contract number AID-268-C-17-00001, is soliciting proposals from **local Lebanese firms** that can support our clients on the below scope of work.

Offerors are responsible for ensuring that their offers are received by Chemonics in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

Offerors should take note that this RFQ does not obligate Chemonics to execute a subcontract nor does it commit Chemonics to pay for any costs incurred in the preparation and submission of any proposals for this solicitation. Furthermore, Chemonics reserves the right to reject any and all offers, if such action is considered to be in the best interest of Chemonics.

2. **Offer Deadline and Protocol:** Offerors shall submit their proposals electronically in accordance with the instructions below:
  - **Technical and financial** offers must be received no later than 4 pm local Beirut time on **February 15, 2021** by email to [LEDprocurement@lebanon-edp.com](mailto:LEDprocurement@lebanon-edp.com)
  - **Technical offer ONLY shall be submitted to the client.** It is the responsibility of the offeror to share contact information of the client and send the technical offer before the above-mentioned deadline.

Please reference the RFQ number **188** in any response to this RFQ. Offers received after the specified time and date will be considered late and will be considered only at the discretion of Chemonics.

3. **Questions:** Questions regarding the technical should be asked to the client directly during site visit & questions regarding administrative requirements of this RFQ may be submitted no later than 4 pm local Beirut time on **February 12, 2021** by email to [LEDprocurement@lebanon-edp.com](mailto:LEDprocurement@lebanon-edp.com) Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the responses thereto—that Chemonics believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding.

Only the written answers issued by Chemonics will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Chemonics or any other entity should not be considered as an official response to any questions regarding this RFQ.

4. **Scope of Work:** Section 3 contains the scope of work of the required service.
5. **Quotations:** Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery and all other costs. **Pricing must be presented in USD** and offers must remain valid for not less than thirty (30) calendar days after the offer deadline. Offerors are requested to provide quotations on their official quotation format or letterhead;

In addition, offerors responding to this RFQ are requested to submit the following:

- Organizations responding to this RFQ are requested to submit a copy of their official registration or business license.

6. **Taxes and VAT:** The agreement under which this procurement is financed is not exempt from the payment of taxes, tariffs, duties, or other levies imposed by any laws in effect in the Cooperating Country. Therefore, offerors must include taxes, charges, tariffs, duties and levies in accordance with the laws of the Cooperating Country.
7. **Eligibility:** By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Chemonics will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.
8. **Evaluation Criteria:** The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the following evaluation criteria. The relative importance of each individual criterion is indicated by the number of points below
  1. *Cost: 30 Points*
  2. *Offeror's qualification, expertise & past experience: 20 Points*
  3. *Scope of Work: 25 Points*
  4. *Site Visit & Client feedback: 20 Points*
  5. *Timeline & Days of Intervention: 5 Points*

Follow-up discussions may be conducted with several Consultant(s) to resolve any questions, finalize the scope of work and agreement on final not-to-exceed costs as a means to recommend final selection to Chemonics.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed “non-responsive” and thereby disqualified from consideration. Chemonics reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, Chemonics reserves the right to conduct any of the following:

- Chemonics may conduct negotiations with and/or request clarifications from any offeror prior to award.
- While preference will be given to offerors who can address the full technical requirements of this RFQ, Chemonics may issue a partial award or split the award among various suppliers, if in the best interest of the Lebanon LED Project.
- Chemonics may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror understands that USAID is not a party to this solicitation and the offeror agrees that any protest hereunder must be presented—in writing with full explanations—to the Lebanon-LED Project for consideration, as USAID will not consider protests regarding procurements carried out by implementing partners. Chemonics, at its sole discretion, will make a final decision on the protest for this procurement.

9. **Terms and Conditions:** This is a Request for Proposal only. Issuance of this RFQ does not in any way obligate Chemonics, the LED Project, or USAID to make an award or pay for costs incurred by potential offerors in the preparation and submission of an offer.

This solicitation is subject to Chemonics' standard terms and conditions. Any resultant award will be governed by these terms and conditions; a copy of the full terms and conditions is available upon request.

#### ***A- Description of the Client***

##### **Food, Beverage, and Entertainment SAL**

##### **Waqf St Georges, Jounieh, Mount Lebanon**

Food, Beverage, and Entertainment (FBE) is a hospitality company that oversees all needed business operations for Crepaway and Nasma, in addition to other clients. Since 1984, Crepaway grew to become one of the most iconic casual restaurants in the region, serving a famous line of mouthwatering appetizers, salads, crêpes, burgers, sandwiches, platters, and desserts. It now has 16 branches distributed all over Lebanon. Nasma offers authentic Lebanese recipes and fresh local ingredients, cooked and presented in beautifully revisited dishes. Their ingredients are of premium quality, supplied from various Lebanese villages. Nasma offers exceptional service to its clientele, in a cozy and welcoming ambiance, where tradition is once again refreshed with a contemporary twist. Nasma now has 3 branches in Lebanon located in Hazmieh, Broumana, and Dbayeh.

FBE operations are distributed on 4 different levels. First come the operations and management tasks which include operating the restaurants in full compliance with the brand operations manual and standards of quality, front of the house that includes outlet management, and back of the house that includes accounting, HR and training, menu development, procurement, IT, food safety and sanitation, administration and liaison with official entities. The second level is the central kitchen, this level contains preparing portions, cooking sauces & desserts, in addition to all sub-recipes, with daily delivery to branches. Third, comes the warehouse that includes stocking sufficient par levels of all items needed in the operation such as packaging, uniforms, dry food, etc. with daily delivery to branches. Last, comes the communication operations where developing brand-building campaigns and various marketing activities to promote the restaurants and boost sales is the main task.

The franchisees of Crepaway in Nigeria, Sulaymaniyah, and Qatar are supplying themselves from local suppliers in their countries with sub-recipes and food ingredients that are key to set the menu for Crepaway. They are looking forward to importing the required and available sub-recipes such as mayonnaise, chocolate spread, frozen scallops, hommos, sauces, etc. from FBE directly.

Within the procurement cycle, FBE needs technical support to better control purchases, upgrade supplier relationships, identify new suppliers, and replacements for costly and/or unavailable supplies. On this level, the company believes they have room for major improvements which will significantly reduce their costs, allow them to reach profitability while being able to offer more affordable prices to customers, and remain competitive in the market. Some challenges lie within the upgrade of FBE's central kitchen processes, allowing them to export their sub-recipes to regional franchises, bringing in fresh income for the company. FBE needs to enhance their know-how to upstream their exportability requirements and optimize their export process, therefore they are afraid that this would lead to an unfavorable agreement that can hurt their profit margins.

LED will cost-share with FBE to hire a consultancy firm that will work with the company's management on optimizing their value chain, supply chain, and production process through the optimal placement of inventory within the supply chain, minimizing operating costs including manufacturing costs, transportation costs, and distribution costs, and determining what's to be outsourced or done inhouse. Moreover, the consultancy firm will work with the management on

optimizing their export process by determining the requirements for upstream exportability. The main challenges to be tackled to enhance the export process of the company are to technically prolong expiry dates and sterilize the packaging process, identify which products have a better chance of making it to the export list, identify which packaging types are more cost-efficient, suitable for export and practical for operation, how to ship fresh goods and what are the costs and taxes involved, and all administrative requisites such as labeling and criteria to display for a successful shipment.

### **Site Visit**
