The Envelope should include the following Documents:

- 1. Data sheets for each requested item. Mandatory
- 2. This RFQ all the pages should be signed and stamped.
- 3. Annex C-financial offer form fully and accurately filled in, signed and stamped.

In addition to the documents indicated above, new suppliers who are not registered in SAWA's supplier database must provide the following:

- Copy of company registration.
- Copy of tax registration (Ministry of Finance).
- Copy of VAT registration (Ministry of Finance).
- Annex E- list of reference including name, phone number, and proof of the specific collaboration **fully and** accurately filled in, signed and stamped.
