Section 1: Instructions to Offerors

1. <u>Introduction</u>: Chemonics, through Chemonics Beirut S.A.R.L., acting on behalf of the U.S. Agency for International Development (USAID) and the Lebanon Enterprise Development (LED) Project, under contract number AID-268-C-17-00001, is soliciting proposals from **local Lebanese firms** that can support our clients on the below scope of work.

Offerors are responsible for ensuring that their offers are received by Chemonics in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

Offerors should take note that this RFQ does not obligate Chemonics to execute a subcontract nor does it commit Chemonics to pay for any costs incurred in the preparation and submission of any proposals for this solicitation. Furthermore, Chemonics reserves the right to reject any and all offers, if such action is considered to be in the best interest of Chemonics.

- 2. <u>Offer Deadline and Protocol</u>: Offerors shall submit their proposals electronically in accordance with the instructions below:
 - Technical and financial offers must be received no later than 4 pm local Beirut time on July 15, 2021 by email to LEDprocurement@lebanon-edp.com
 - Technical offer ONLY shall be submitted to the client. It is the responsibility of the offeror
 to share contact information of the client and send the technical offer before the abovementioned deadline.

Please reference the RFQ number **265** in any response to this RFQ. Offers received after the specified time and date will be considered late and will be considered only at the discretion of Chemonics.

- 3. Questions: Questions regarding the technical should be asked to the client directly during site visit & questions regarding administrative requirements of this RFQ may be submitted no later than 4 pm local Beirut time on July 13, 2021 by email to LEDprocurement@lebanon-edp.com
 Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the responses thereto—that Chemonics believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding. Only the written answers issued by Chemonics will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Chemonics or any other entity should not be considered as an official response to any questions regarding this RFQ.
- 4. **Scope of Work**: Section 3 contains the scope of work of the required service.
- 5. **Quotations**: Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery and all other costs. **Pricing must be presented in USD** and offers must remain valid for not less than thirty (30) calendar days after the offer deadline. Offerors are requested to provide quotations on their official quotation format or letterhead;

In addition, offerors responding to this RFQ are requested to submit the following:

- Organizations responding to this RFQ are requested to submit a copy of their official registration or business license.
- Individuals responding to this RFQ are requested to submit a copy of their identification card along with MOF registration if applicable.

- 6. <u>Taxes and VAT</u>: The agreement under which this procurement is financed is not exempt from the payment of taxes, tariffs, duties, or other levies imposed by any laws in effect in the Cooperating Country. Therefore, offerors must include taxes, charges, tariffs, duties and levies in accordance with the laws of the Cooperating Country.
 - <u>Chemonics Beirut SARL is VAT exempted all invoices issued by your company will be stamped and signed with a special stamp filled in detail as mentioned in the agreement with the ministry of finance.</u>
- 7. **Eligibility**: By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Chemonics will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.
- 8. **Evaluation Criteria**: The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the following evaluation criteria. The relative importance of each individual criterion is indicated by the number of points below
 - 1. Cost: 30 Points
 - 2. Offeror's qualification, expertise & past experience: 20 Points
 - 3. Scope of Work: 25 Points
 - 4. Site Visit & Client feedback: 20 Points5. Timeline & Days of Intervention: 5 Points

Follow-up discussions may be conducted with several Consultant(s) to resolve any questions, finalize the scope of work and agreement on final not-to-exceed costs as a means to recommend final selection to Chemonics.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. Chemonics reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, Chemonics reserves the right to conduct any of the following:

- Chemonics may conduct negotiations with and/or request clarifications from any offeror prior to award.
- While preference will be given to offerors who can address the full technical requirements of this RFQ, Chemonics may issue a partial award or split the award among various suppliers, if in the best interest of the Lebanon LED Project.
- Chemonics may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror understands that USAID is not a party to this solicitation and the offeror agrees that any protest hereunder must be presented—in writing with full explanations—to the Lebanon-LED Project for consideration, as USAID will not consider protests regarding procurements carried out by implementing partners. Chemonics, at its sole discretion, will make a final decision on the protest for this procurement.

9. <u>Terms and Conditions</u>: This is a Request for Proposal only. Issuance of this RFQ does not in any way obligate Chemonics, the LED Project, or USAID to make an award or pay for costs incurred by potential offerors in the preparation and submission of an offer.

Section 3: Scope of Work

A- Description of the Client

Shelvz SAL Beirut, Bechara El Khoury Street, Beirut Digital District, Building 1243

The 2016 winner of Seedstars Lebanon, Shelvz is an all-in-one cloud solution aimed at automating the data collection process of mobile field teams to provide real-time visibility and analytics to businesses. The company improves the way brands handle their merchandising, sales, and promotion efforts by offering a field-force management solution that optimizes every step of the process, every second of the day. Armed with data and supported by technology, Shelvz's clients have the increased ability to make timely decisions that have changed the course of their businesses.

Shelvz started in 2016 when Café Najjar requested a technology to monitor their field representatives and process their data. The team behind Shelvz developed an MVP (minimum viable product) and incorporated Shelvz SAL in 2017 after receiving a seed investment from B&Y venture partners.

Shelvz is a cloud-based field force management solution that automates the data collection process with a focus on the FMCG industry. Field representatives of FMCG companies are provided with Shelvz platform during their daily visit to the point of sales (supermarket, grocery, pharmacy) to perform various activities and collect data related to products such as expiries, unavailability, shelf share, stock, pricing, etc... Through this platform, Shelvz allows companies to monitor and optimize their team productivity (routing coverage, travel/idle time, visit time, etc.) and give visibility of their products in their point of sales (unavailability trends, Sales loss due to inefficiencies, compliance reports, etc.) through a dashboard. Also, their clients can benefit from the notification engine where they can be informed of any critical data via email/Whatsapp/telegram immediately. The company's revenue model is based on a monthly subscription per field representative and an onboarding fee per client.

Shelvz is now present in 4 markets (KSA/Lebanon/Egypt/Kuwait) with major clients and traction in the FMCG industry. Currently, the management is raising a Series A round and wants to prepare the company for scaling very rapidly. Shelvz is targeting big names in this sector such as multinational companies and large chains;

Shelvz is in contact with several new potential clients in Lebanon and abroad.

The new deals are done on a similar basis; the buyers will be subscribing to the retail execution solution where they pay Shelvz a monthly fee based on the number of field rep users and a one-off onboarding fee.

Shelvz is now targeting major FMCG players to increase the value of its portfolio and grow on a multinational level. Following that step, the management noticed that branding/marketing and online presence will play a key role in client acquisition especially with regards to credibility when comparing to what major competitors are doing. Their competitors have a very significant presence online and focus a lot on branding and the company's image. The branding of Shelvz is not up-to-date with the fast-moving environment of the industry, and the online presence is weak. The company

needs a rebranding and upgrade to the brand image and online presence to appear appealing to major multinational FMCG companies.

LED will cost-share with Shelvz to hire a consulting firm specializing in branding that will work with the management of 3 main pillars.

- 1st pillar: the consultant will work on enhancing the Marketing material such as Pitch Deck Revamp, Company Presentation Revamp (Multilingual), Online Proposals revamp, News Letters/Quarterly review of data analytics, Branding guidelines, Website Full redesign (Multilingual), Explore other means of marketing (Exhibitions, etc.) relevant to Shelvz.
- 2nd pillar: the expert will support in improving the Product image such as Web Portal Revamp, Mobile app Revamp, UI & UX improvement, New product releases, New reporting, Training materials (Online knowledge base with FAQ).
- 3rd pillar: the expert will help in content creation such as Social Media management, Blog writing, Case studies, Video (product overview & other), Online comparison websites, Retail websites, Article writing when relevant.

B- Site Visit

Site visit or conference call with the client for this requirement is mandatory. If you submit a tender without having attended the site visit or making a conference call, your bid may be deemed non-compliant and will not be considered.

To arrange a visit or conference call, please coordinate with our business advisor for each client before the deadline.
