#### **Section 1: Instructions to Offerors**

Introduction: Chemonics, through Chemonics Beirut S.A.R.L., acting on behalf of the U.S. Agency
for International Development (USAID) and the Lebanon Enterprise Development (LED) Project,
under contract number AID-268-C-17-00001, is soliciting proposals from local Lebanese firms
that can support our clients on the below scope of work.

Offerors are responsible for ensuring that their offers are received by Chemonics in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

Offerors should take note that this RFQ does not obligate Chemonics to execute a subcontract nor does it commit Chemonics to pay for any costs incurred in the preparation and submission of any proposals for this solicitation. Furthermore, Chemonics reserves the right to reject any and all offers, if such action is considered to be in the best interest of Chemonics.

- 2. <u>Offer Deadline and Protocol</u>: Offerors shall submit their proposals electronically in accordance with the instructions below:

  - Technical offer ONLY shall be submitted to the client. It is the responsibility of the offeror
    to share contact information of the client and send the technical offer before the abovementioned deadline.

Please reference the RFQ number **307** in any response to this RFQ. Offers received after the specified time and date will be considered late and will be considered only at the discretion of Chemonics.

- 3. Questions: Questions regarding the technical should be asked to the client directly during site visit & questions regarding administrative requirements of this RFQ may be submitted no later than 4 pm local Beirut time on January 4, 2022 by email to <a href="LEDprocurement@lebanon-edp.com">LEDprocurement@lebanon-edp.com</a> Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the responses thereto—that Chemonics believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding. Only the written answers issued by Chemonics will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Chemonics or any other entity should not be considered as an official response to any questions regarding this RFQ.
- 4. **Scope of Work**: Section 3 contains the scope of work of the required service.
- 5. **Quotations**: Quotations in response to this RFQ must be prized on a fixed-prize, all-inclusive basis, including delivery and all other costs. **Pricing must be presented in USD** and offers must remain valid for not less than thirty (30) calendar days after the offer deadline. Offerors are requested to provide quotations on their official quotation format or letterhead;

In addition, offerors responding to this RFQ are requested to submit the following:

- Organizations responding to this RFQ are requested to submit a copy of their official registration or business license.
- Individuals responding to this RFQ are requested to submit a copy of their identification card along with MOF registration if applicable.

- 6. <u>Taxes and VAT</u>: The agreement under which this procurement is financed is not exempt from the payment of taxes, tariffs, duties, or other levies imposed by any laws in effect in the Cooperating Country. Therefore, offerors must include taxes, charges, tariffs, duties and levies in accordance with the laws of the Cooperating Country.
  - <u>Chemonics Beirut SARL is VAT exempted all invoices issued by your company will be stamped and signed with a special stamp filled in detail as mentioned in the agreement with the ministry of finance.</u>
- 7. **Eligibility**: By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Chemonics will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.
- 8. **Evaluation Criteria**: The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the following evaluation criteria. The relative importance of each individual criterion is indicated by the number of points below
  - 1. Cost: 30 Points
  - 2. Offeror's qualification, expertise & past experience: 20 Points
  - 3. Scope of Work: 25 Points
  - 4. Site Visit & Client feedback: 20 Points5. Timeline & Days of Intervention: 5 Points

#### N.B: the TA timeline must not exceed end of June 2022

Follow-up discussions may be conducted with several Consultant(s) to resolve any questions, finalize the scope of work and agreement on final not-to-exceed costs as a means to recommend final selection to Chemonics.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. Chemonics reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, Chemonics reserves the right to conduct any of the following:

- Chemonics may conduct negotiations with and/or request clarifications from any offeror prior to award.
- While preference will be given to offerors who can address the full technical requirements of this RFQ, Chemonics may issue a partial award or split the award among various suppliers, if in the best interest of the Lebanon LED Project.
- Chemonics may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror understands that USAID is not a party to this solicitation and the offeror agrees that any protest hereunder must be presented—in writing with full explanations—to the Lebanon-LED Project for consideration, as USAID will not consider protests regarding procurements carried out by implementing partners. Chemonics, at its sole discretion, will make a final decision on the protest for this procurement.

### A- Description of the Client

## Falafel Freiha Company Achrafieh, Hayek Building, facing ABC Mall

Falafel Freiha is a family-owned and operated business founded in 1945 in Old Down Town Beirut. In 1979, they opened another branch in Achrafiyeh, in one of the oldest and busiest districts of Beirut, currently facing ABC mall. With time this business became one of the representatives of the traditional Lebanese cuisine, a street food destination for the locals and for the tourists. Throughout the years, the owners kept the authenticity in the recipe and in the experience. This place boomed among tourists looking for traditional Lebanese food, especially the ones looking for a vegetarian and healthy meal. They opened another branch in Broumana mainly targeting the busy summer tourist attraction area. Currently, they are receiving interest to branch out to KSA and France, where they will positively convey the traditional Lebanese food and culture. Also, there is a high demand for vegetarian, healthy, and affordable meals, especially in Paris.

Some interested buyers are interested in opening several branches. For France, it is expected to be a full franchise deal, with a target of 1 branch in the first year and a possible 1 or 2 more in the following year. The branches will be located in Paris. For KSA, the deal is to open 2 branches in Riyadh in the first year with a potential of another 2 in the following year. They are negotiating a 'Manchise' agreement, in which Freiha will conduct the management and kitchen operation and the Saudi partner will handle the logistics and the financials.

Being a family business, the company lacks the proper structure for these expansions. They also lack the flexibility to adapt to different types of partnerships. While they are experts in the kitchen, their current organization and system of processes will not allow them to confidently expand over various geographical locations along with the different legal aspects that will arise from these deals. They also don't possess the full details of the targeted markets.

LED to cost-share with the client the cost of a consultancy firm able to identify and enhance the weaknesses currently present in the client's organization. The consultancy firm will work on the governance of the company and the legal frameworks to finalize the deals. The consultancy firm must be an expert in the FnB business and an expert in the targeted Markets, KSA & France. Some key areas of focus are:

- Financial Model
- Market study and competitor analysis for KSA (Riyadh) and France (Paris).
- Corporate Governance
- Management Agreement format
- Shareholders agreement format.
- Internal Management Processes.

#### Rim Mills Najib Saliba Sons LLC Bekaa-Kaa El Rim

Rim Mills Najib Saliba Sons is a known company in Bekaa, a third-generation family business in the food industry that has been in operation since 1952. The company produces high-quality burgul and moughrabieh. Lately, the company upgraded its production lines and equipped its processing factory with state-of-the-art automated machinery, which allowed it to become the first automated

producer of burgul in Lebanon and now the company is planning to upgrade its old traditional moughrabieh production lines into a new automated process.

The primary objective of the organization is to work on the social and economic wellbeing of the wheat farmers in the region by further developing their farming information essentially regarding the hard and soft wheat, expanding their creation through preparing and giving legitimate seeds, purchasing from them the whole harvest at decent prices which is higher than the market average price, for the farmers to be able to sustain their businesses and provide good quality products to the mills.

Rim Mills is already investing in upgrading its production lines from old-fashioned drying on the roofs into a fully automated process; thus it is a completely sterile process/ product.

Today, the company is working on exporting a large percentage of its products in several markets abroad and is working diligently on promoting the Lebanese burgul and moughrableh in new countries.

Rim Mills is negotiating with several international buyers, In addition, the company is working to close deals with NGOs and INGOs.

The new buyers will be buying from Rim Mills, high-quality burgul and moughrabieh.

Rim Mills is already investing in upgrading its production lines. In addition, the production capacity of the factory is improved to serve the export. For the company to be able to achieve a significant percentage of export, it lacks international business development assistance.

LED will cost-share with Rim Mills to hire a local consultancy firm with high expertise in the company products, who will assist the company set a proper sales and business development strategy for them to penetrate new international markets. The consultancy firm will work on defining the company strengths and the most suitable markets to penetrate and then will set the strategy and action plan to do so. He will set the KPIs for the sales team, job descriptions, and so forth. The consultancy firm will train the sales team, the newcomers, and the company management on the latest international sales skills and trends.
