The main objective of this project is to improve the safety and well-being of children living in Aley district by reducing their vulnerability to abuse and exploitation. In addition to that, it aims to increase awareness among parents, caregivers, and community members about child protection issues, including identifying and reporting child abuse and exploitation. Simultaneously, the project will strengthen the capacity of child protection services to prevent, identify, and respond to cases of child abuse and exploitation.

- *Price 70%:* The overall cost presented in the offer.
