The Office of the United Nations High Commissioner for Refugees (UNHCR), established on 14 December 1950 by the United Nations General Assembly1, requests your price quotation for Metal Garbage Bins (1,200 Liters capacity) specified in this Request for Quotation (RFQ).

1. REQUIREMENTS

Description: Metal Garbage Bins (1,200 Liters capacity)

Delivery point: DAP - UNHCR Zahle/Taanayel warehouse

The deadline for receipt of questions is on Friday **19 August 2022 at 16:00 Hrs local time**. UNHCR may, at its discretion, copy any reply to a particular question to all other invited bidders.

3. BID EVALUATION:

All bids will be evaluated based on compliance with the established UNHCR Requirements and price.

Pass / Fail criteria:

- 1. Company must be registered with the Government of Lebanon (GoL);
- 2. Company should have at least three (3) years of experience in providing similar goods;
- Signing and stamping Annex A to indicate the acceptance of the company on our requirements;
- 4. Company must submit technical data sheets including drawings which indicate all specifications of the quoted metal garbage bins;
- 5. The wheels should be branded quality and the company must submit the technical datasheets for the quoted wheels
- 6. Company <u>must submit sample for a metal garbage bin with wheels</u>, as per the technical requirements;
- 7. Company must fill, sign, stamp and submit the Vendor Registration Form (Annex D), in case they are not registered in UNCHR vendor database;
- 8. Company must sign, stamp and submit UNHCR's General Conditions for the provision of Goods (Annex E) and UN Supplier Code of Conduct (Annex F);
- 9. Company must fill, sign, stamp and submit Non-Sanction Clearance Form (Annex G);
- 10. Company must submit written statement that the company accepts the delivery Incoterms (Delivered At Place-DAP) to UNHCR Zahle warehouse in Central Bekaa;
- 11. Company must submit written statement confirming the delivery lead-time from the date of purchase order. Please note that bidders with shorter delivery lead time will be given higher consideration.

Failure to submit all of the above (including sample) by the closing date **31 August 2022, 16:00 Hrs** (**Lebanon local time**), may result in disqualifying your offer.

All bids must be received latest by 31 August 2022, 16:00 Hrs (Lebanon local time) or earlier.

Your quotation must be valid as least for **60 days**. The standard payment term of UNHCR is within 30 days upon satisfactory delivery of goods or services and acceptance thereof by UNHCR.

BID ACCEPTANCE: UNHCR reserves the right to accept the whole or part of your bid. The lowest tender needs not to be accepted.
