The project will provide child protection services for the most vulnerable Children, youth and their caregivers from the Lebanese and Syrian nationalities living in Aley area. The main objective of this project is to improve the safety and well-being of children living in Aley district by reducing their vulnerability to abuse and exploitation. In addition to that, it aims to increase awareness among parents, caregivers, and community members about child protection issues, including identifying and reporting child abuse and exploitation. Simultaneously, the project will strengthen the capacity of child protection services to prevent, identify, and respond to cases of child abuse and exploitation.

The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the following criteria. The relative importance of each individual criterion is indicated by the number of points below:

- Availability – 20%:* The availability of the documents requested
- Price – 70%:* The overall cost presented in the offer.
