

## **Tenderer's Declaration**

In response to your letter of invitation to tender for the above contract, we, the undersigned, hereby declare that:

- 1. We have examined and accept in full the content of the file for invitation to tender No. RTP/20230601
- 2. In accordance with the terms of the TOR and the conditions and time limits laid down, without reserve or restriction we offer to: provide bids English & Computer Courses for Adolescents and Youth to the service mentioned in RFP file.

- 8. We agree to adhere to all the terms and conditions of the contracting authority as provided in the tender file.
- 9. We confirm that we are not engaged in any corrupt, fraudulent, collusive or coercive practices and acknowledge that if evidence contrary to this exists, Right To Play Int'l reserves the right to terminate the contract with immediate effect.

We are not bankrupt or being wound up, are having our affairs administered by the courts, have not entered an arrangement with creditors, have not suspended business activities, are not the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations.
- 11. We have not been convicted of an offence concerning professional conduct by a judgment which has the force of res judicata.
- 12. We have not been guilty of grave professional misconduct proven by any means which the contracting authority can justify.
