About NOMU Project

Titled "YouthTech Thrive: Empowering Young Talent through Digital Training and Sustainable Job Placement", the NOMU project aims to upskill youth and bridge the skills gap through the provision of accredited and/or industry-recognized certifications that pave the way for better job opportunities, funded by Al Ghourair Foundation and implemented by DOT Lebanon, SE Factory, Zaka AI and NAWAYA. The project aims at building the digital skills of 2005 Lebanese and non-Lebanese youth in all Lebanese areas. Out of 2005, **400 youth** who completed specific digital courses with DOT Lebanon, will be referred for a basic English language course, and 150 will be referred for a business English course), to develop their linguistic skills and be ready for employment opportunities.

Description of the Request

Provision of training on Basic English language for 400 youth aged 18-35 years old.

1. Technical Description

The NOMU project is about enabling youth with digital, linguistic, and life skills to be ready for future jobs, whether freelance, full-time, or part-time employment. The youth we work with are either Lebanese and refugees.

The enrolled beneficiaries who accessed DOT Lebanon digital courses will be selected to access the Basic English language program.

Age group: 18-35

Geographical area: All over Lebanon

Educational background: school-aged, university students, university dropouts, and

university graduates.

Total number of hours per group: between 36 to 60 hours.

Provision of training on Business English language for 150 youth aged 18-35 years old.

2. Technical Description

The NOMU project is about enabling youth with digital, linguistic, and life skills to be ready for future jobs, whether freelance, full-time, or part-time employment. The youth we work with are either Lebanese and refugees.

The enrolled beneficiaries who accessed DOT Lebanon digital courses will be selected to access the Business English language program.

Age group: 18-35

Geographical area: All over Lebanon

Educational background: school-aged, university students, university dropouts, and

university graduates.

Total number of hours per group: between 36 to 60 hours.



About the Training:

<u>Training</u>:

Business English: that serves the needs of the trainees and equips them with the specialized language and communication skills required in professional settings.

Basic English: that serves the needs of the trainees and equips them with essential language skills for effective communication in various everyday situations, fostering their confidence and proficiency.

<u>Modality:</u> Training courses shall be delivered on-site to Lebanese and non-Lebanese beneficiaries (in community centers identified by DOT Lebanon).

<u>Examination</u>: Requirements to have a pre and post-test to assess the level of the trainee and group the trainees as per their levels.

<u>Duration</u>: The full-service delivery term is from April 2024 to October 2025 (exact start and end dates to be determined).

<u>Instructors</u>: The instructor shall:

- Have the expertise to deliver training on-site for various beneficiaries (Lebanese and non-Lebanese with different backgrounds)
- Have the skills to manage youth inside a classroom.
- Have the skills to work with youth from different areas and backgrounds.
- Have the skills to deliver the training in an interactive way.

3. Tenderer Profile

Interested entities providing English language services who meet the minimum requirements below are invited to respond to this request in full. The full proposal includes all the activities listed in Table 1 for the duration of the training delivery term:

- Valid registered business (Company and/or NGO)
- Training experience in the following topics: Basic English Language and Business English language (Grammar & Business) mainly on-site.
- Qualified trainers to provide such training with certifications.
- Proven experience in giving English language training courses
- Excellent logistical capabilities to manage youth during sessions inside the classroom.

- 2. Each bid should include the below and addressed to the Procurement Person:

 - b. Entity Profile (Experience with NGOs is a plus)
 - c. Certificates (Training Accreditation, Registration of the business/NGO, any other certificates)
 - d. CV of the trainer/trainers and descriptive literature of the offered training program
 - e. A presentation about previous similar work assignments and with NGOs
 - f. If VAT is applicable, please attach a copy of the VAT certificate or mention the VAT registration no. on your bid
 - g. Payment Terms
 - h. Validity
- 3. An authorized service provider representative must sign, stamp, and date the bid, and other related documents accompanying it.
