Confidentiality

Information relating to the evaluation of tenders shall not be disclosed to tenderers or any other persons not officially concerned with such process until information on contract award is communicated to all tenderers.

Any attempt by a tenderer to improperly influence the employer in the evaluation of the tenders or contract award decisions may result in the rejection of its tender.

Clarification of Tenders

To assist in the examination, evaluation, and comparison of the tenders and qualification of the tenderers, the employer may, at its discretion, ask any tenderer for a clarification of its tender, allowing a reasonable time for response. Any clarification submitted by a tenderer that is not in response to a request by the employer shall not be considered. The employer's request for clarification and the response shall be in writing. No change in the prices or substance of the tender shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by the employer in the evaluation of the tenders.

Conditions

- 1. DOT Lebanon General Conditions of Contract shall apply.
- 2. If the Tenderer is successful, this RFP shall constitute the basis of an agreement for the services as listed above.
- 3. Payment for services shall be made within 15 working days after the submission of the invoice. And after completion of services provided that DOT has received an appropriate original invoice from seller and delivery vouchers duly signed by representatives of both parties.
- 4. DOT Lebanon is not bound to accept the lowest or any other offer and reserves the right to accept any offers in part or in whole.



- 5. Samples of offers when required will be provided free and before the closing date of the tender. If not destroyed during tests they will, upon request, be returned at the seller's expense, or may be collected by the seller.
- 6. Making a payment to any employee as an inducement or any canvassing to enable you to win this bid will result in automatic disqualification from participating in this tender or any other tender.
- 7. Quotations with missing information will be disqualified from participating in this tender.
- 8. An authorized representative of the seller must sign, stamp and date the quotation, and other relative documents accompanying it.
- 9. If you were not contacted after 30 working days from the closing date, then be notified that your offer was not selected.
