Overview

CARE established its presence in Lebanon in 2006 and has been responding to the Syrian Crisis since late 2012. Among CARE's key imperatives is putting people it serves first through implementing cutting edge programming in areas it operates. CARE currently carries out activities in Beirut, Mount Lebanon, Akkar, North Lebanon, South Lebanon, and the Beqaa Valley. CARE implements both emergency and development projects contributing to livelihood, food security, protection, gender, shelter, and water, sanitation, and hygiene. It targets the most vulnerable people and populations, both host communities and refugees. Over the course of 7 years, it has supported over than half a million beneficiaries. In Lebanon, CARE's program strategy for the upcoming years will focus on strengthening and expanding its emergency response and capacity to provide basic assistance services while pursuing development projects in areas of food security and livelihood support, gender, and protection. CARE intends to maintain its presence in all areas of Lebanon. CARE Lebanon has scaled up rapidly over the past few years and today it has about 90 staff members, with more than 15 different local/international partner organizations. 90% of the team is composed of national staff, with a symbolic number of international members.

Objective:

The objective is to conclude a framework agreement with a supplier for a period of either 1 year or for 2 years starting January 1st, 2024. The end of the contract will be specified based on the applications and the availability of items maintained by the bidder.

A BOQ reflecting the items required is annexed for reference.

Application/ Instructions to Bidders:

Interested bidders are invited to apply by sending samples of each item within the annexed BOQ reflecting the following:

- A quotation reflecting the prices per item.
- Samples of each item are required.
- Samples to be delivered to the CARE international Lebanon office present at the following address by November 30^{th,} 2023, Close of Business:

- Official registration documents of companies are required.
- Fresh Bank account details are required.
- The deadline for receiving the samples and the quotations is November 30th, 2023.
- The selection of the provider will be on a quality and cost basis as per the following specified percentages.
 - \circ $\;$ Quality of items: 60 % of the total mark of the application per bidder.
 - \circ Cost of items: 40% of the total mark of the application per bidder.

- The provider is expected to have the items available throughout the contract period.
- Orders will be requested based on purchasing goodie bags that consist of several items together in 1 bag per order which will be delivered to the activity sites and locations.
- Orders will be requested by purchasing some items for the office.
- Expiry date of items should be a minimum of 6 months.
