2. Background on the organization and the project

Right to Play is a global organization committed to improving the lives of children and youth affected by conflict, disease and poverty. Established in 2000, Right to Play has pioneered unique play-based approach to learning and development which focuses on quality education, life skills, health, gender equality, child protection and building peaceful communities.

Right to Play is implementing the Enhancing Quality and Inclusive Education (EQIE) program in 5 countries, including Lebanon over four-years (2020-2024). In Lebanon, the program is implemented in educational institutions in Palestinian refugee camps in Beirut, North and South governorates.

Objectives of the EQIE project:

- Improving learning outcomes of boys and girls, in pre-primary and lower primary school years;
- Increasing retention of out-of-school girls and children with disabilities,

3. Research Objectives

This research study is restricted to Lebanon and aims at exploring the play-based learning (PBL) approach in early childhood development, to:

- Study the impact of PBL approach on child development in early years;
- Study the effect of PBL on teaching practices, and on the physical and emotional safety of learning spaces.

Suggested research objectives are to be revised and updated based on the anticipated desk review.

4. Methodology and scope

A mixed method approach, consisting of qualitative and quantitative data, leading to statistical and explanatory significant results is envisioned. The methodology should include a desk-study and design phase in which existing data and information is used as a starting point for designing the full research plan. A longitudinal study (3 years) with comparative control groups is recommended. The sample size should be representative to the overall targeted population.



The research is expected to take place in parallel to EQIE project implementation, which targets 15 kindergartens with a total of 1560 children participants aged 3 to 6 years old.

Data collection tools are expected to be based on play-based methodologies, and adapted to the age group of children involved.

While several phases of data collection are suggested, applicants of this consultancy are applying for phase 1 only, and the anticipated number of days is 25-30 working days.

6. Qualifications of the consultant

A consultant is needed with the following competencies and experience:

- Evidence of experience in conducting quantitative and qualitative research;
- Strong facilitation skills, particularly with regards to working with young children and adults in vulnerable communities;
- Masters or PhD degree in a relevant field (e.g., Public Health, Social Sciences or any related technical field);
- Demonstrated understanding and support of principles of equity, participation and inclusion;
- Good writing skills;
- Fluency in English and Arabic is mandatory;
- Experience in working with early childhood development settings is a strong asset.

- Narrative proposal (2 pages) including overall plan for developing the research methodology, input on the suggested research design, capacity to deliver products as per the design described above and the roles of the team members or research partners' to be involved;

- MOF registration number if available;
- The financial proposal needs to be stamped and signed;
- CV of key persons involved and the portfolio of the organization if relevant.
