#### **Background and Justification**

The Marine and Coastal Management programme at IUCN ROWA is currently implementing a Norwegian funded project in Lebanon regarding coastal ecosystem resilience to climate change. This project aims to reduce the vulnerability of selected coastal towns in Lebanon, which are facing crucial sustainability issues.

In line with the objectives of the project, the Marine Programme is providing institutional assistance to local government to ratify and update the international conventions and include them into national legislation. Accordingly, IUCN is looking for a local legal expert to provide input for identification gaps and construction of recommendations within the baseline legal assessment of national legislation and institutional arrangements regarding marine environment and the conservation and protection of marine natural resources and sustainable fishing in Lebanon.

## Scope of Work and Objectives.

Under the direction of Marine Programme Manager, the expert will do the following but not limited to:

- Collect, analyse and share information on the current legal, policy, and institutional framework regarding marine conservation international legal instruments in Lebanon, including: International signed, adopted, or ratified instruments; national legislation framework for implementation; institutional framework; and ongoing political and legal processes. Methodology should include desk research, interviews, surveys, field visits, and/or other methods as appropriate.
- Develop a matrix of legal and policy instruments relevant to international conventions in relation with marine conservation in Lebanon, according to guidelines agreed with IUCN Environmental Law Center (ELC).
- Identify gaps in the current implementation of marine conservation international instruments in relation with the national legislation framework. (including potential needs for new regulations or policies, modification of current regulations, adoption of additional international instruments, or others identified by the consultant).
- Prepare a final report with results of the conducted analysis of legal instruments in relation with marine conservation in Lebanon, according to guidelines agreed with ELC

At least a proven record of work of a minimum of 5-year experience in the legal environmental field. The applicant must have a legal background (Law, political studies, public policy and other environmental policy related degrees ...)
