

Title: Skin and nail care Trainer

Project: *Economic strengthening and social stability of vulnerable local and displaced communities in South Lebanon*

Purpose

ADR is seeking to hire a full time “Skin and nail care Trainer” in the framework of the project *Economic strengthening and social stability of vulnerable local and displaced communities in South Lebanon* implemented in partnership with Fundación Promoción Social (FPS) together with the Spanish NGO AIDA and aims to Contribute to strengthening the stability of the socio-economic environment in the Southern Region of Lebanon, creating opportunities for women and youth, both Syrian and Lebanese, and helping to reduce internal tensions.

Background
